संख्या: टी.एस.एम-एफ(6) 6/2024.—चूंकि, भूमि अर्जन, पुनर्वासन और पुनर्व्यवस्थापन में उचित प्रतिकर और पारदर्शिता अधिकार अधिनियम, 2013 (जिसे इसमें इसके पश्चात् उक्त नियम कहा गया है) की 113-राजपत्र / 2025-27-08-2025 (5045)

धारा 19 की उप-धारा (1) के अधीन, जिला कांगड़ा के गगगल हवाई अड्डे के विस्तारीकरण से सम्बद्ध भूमि अर्जन की घोषणा तारीख 16-08-2024 को प्रकाशित की गई थी, जिसके द्वारा जिला कांगड़ा के 14 गांवों (तहसील कांगड़ा के 10 गांवों और तहसील शाहपुर के 04 गांवों) में अपेक्षित कुल 122-54-86 हैक्टेयर भूमि को नामतः कांगड़ा हवाई अड्डे के विस्तारीकरण के प्रयोजन हेतु भूमि अर्जन हेतु अधिसूचित किया गया था।

और, उक्त अधिनियम की धारा 25 के उपबन्धों के अनुसार, कलक्टर को उक्त घोषणा की तारीख अर्थात् 16-08-2024 से बारह मास की अवधि के भीतर अधिनिर्णय करना अपेक्षित है ऐसा न होने पर भूमि के अर्जन की समस्त प्रक्रियाएं व्यपगत हो जाएंगी:

परन्तु समुचित सरकार को बारह मास की अवधि बढ़ाने की शक्ति होगी, यदि उसकी राय में ऐसी परिस्थितियां विद्यमान हैं, जो उसे न्यायोचित ठहराती हैं। और अपरिहार्य प्रशासनिक कारणों के कारण नियत अवधि के भीतर अधिनिर्णय नहीं किया जा सका।

अतः, हिमाचल प्रदेश के राज्यपाल, भूमि अर्जन, पुनर्वासन और पुनर्व्यवस्थापन में उचित प्रतिकर और पारदर्शिता का अधिकार अधिनियम, 2013 की धारा 25 के अधीन प्रदत्त शक्तियों का प्रयोग करते हुए, उक्त भूमि अर्जन कार्यवाहियों के बाबत अधिनिर्णय करने की अवधि को बारह मास की और अवधि अर्थात् तारीख 15-08-2026 तक एतद्वारा बढ़ाते हैं।

NOTIFICATION

No. TSM-F(6)-6/2024.—Whereas, under sub-section (1) of Section 19 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (hereinafter referred to as the said Act), the Declaration of acquisition for land pertaining to the expansion of Gaggal Airport, District Kangra, was published on 16-08-2024 by which a total of 122-54-86 hectares land required in the 14 villages (10 villages of Tehsil Kangra and 04 villages of Tehsil Shahpur) of District Kangra was notified for the acquisition of land for the purpose namely, Expansion of Kangra Airport;

And Whereas, as per the provisions of section 25 of the said Act, the Collector is required to make the awards within a period of twelve months from the date of the said declaration *i.e.* 16-08-2024 failing which the entire land acquisition proceedings shall lapse; provided that the appropriate Government shall have the powers to extend the period of twelve months if in its opinion, circumstances exist justifying the same;

And whereas, the award could not be made within the stipulated period due to unavoidable administrative reasons.

Now, therefore, in exercise of powers conferred under Section 25 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, the Governor of Himachal Pradesh hereby extends the period for making the award in respect of the said land acquisition proceedings by a further period of twelve months *i.e.* upto 15-08-2026.
