No. PCH-HA (1)4/2024-29688-33636.—Whereas, the draft Model bye-laws to prescribe provisions to regulate the activities of the rural street vendor and local markets in the rural areas of

Himachal Pradesh, enabling the Gram Panchayat to perform the functions entrusted to it under entry (18) of Schedule–I of Section 11(1) of the Himachal Pradesh Panchayati Raj Act, 1994 were notified *vide* this department notification of even number dated 01-08-2025 and published in Rajpatra (e-Gazette) of Himachal Pradesh on dated 04-08-2025 for inviting objections and suggestions from general public under the provision of Section 188 of the Himachal Pradesh Panchayati Raj Act, 1994 (Act No. 4 of 1994);

And whereas, no objection /suggestion has been received in this behalf during the stipulated period;

Now, therefore, in exercise of the powers conferred by Section 188 of the Himachal Pradesh Panchayati Raj Act, 1994 (Act No. 4 of 1994), the Governor of Himachal Pradesh is pleased to make the following Model bye-laws to prescribe provisions to regulate the activities of the rural street vendor and local markets in the rural areas of Himachal Pradesh, enabling the Gram Panchayat to perform the functions entrusted to it under entry (18) of Schedule –I of Section 11(1) of the Himachal Pradesh Panchayati Raj Act, 1994 namely:—

CHAPTER I: PRELIMINARY

- **1. Short title and extent.**—(1) These bye-laws may be called the Himachal Pradesh Rural Street Vendors Model bye-laws, 2025.—
 - (a) It shall extend to the entire rural area within the administrative boundaries of the Gram Panchayats in Himachal Pradesh.
 - (b) It shall come into force from the date of its adoption and publication by the Gram Panchayat.
 - 2. **Definitions.**—In these Model bye-laws, unless the context otherwise requires,—
 - (a) "appropriate Government" means the Government of Himachal Pradesh.
 - (b) "mobile vendor" means the street vendor who carries out the vending activities, in designated area, by moving from one place to another place, vending the goods and services and this includes, the vendors carrying out their vending activities through mobile vehicles, mechanical and non-mechanical means of transport;
 - (c) "rural street vendor" means the vendor who carries out vending activities, in rural area of Himachal Pradesh and it includes "Mobile Vendor", "Stationary Vendor" and "Street Vendor";
 - (d) "natural market" means a market where sellers and buyers have traditionally congregated for the sale and purchase of products or services and which has been notified by the Gram Panchayat as such;
 - (e) "stationary vendor" means the street vendor who carries out vending activities on regular basis, at a specific location *from a temporary built up structure*. It includes the license holder, parents, spouse and children of the license holder who are above the age of 18 years or such age as may be prescribed by the appropriate Government; and
 - (f) "vending zone" means an area or a place or a location designated as such by the Gram Panchayat, for the specific use by street vendors for street vending and shall include

any area in public park, waiting area for public or any such place, considered suitable for vending activities and providing services to the general public.

CHAPTER II: REGULATION OF STREET VENDING

- 3. The Gram Panchayat, by resolution, passed in its general or special meeting, shall declare such area(s) as vending zone(s), which have reasonably goodfootfall & wherein, space is also available, in form "A" appended with these Model bye-laws. Vending zone shall not to be allowed on footpath, so as to facilitate free movement of general public. Gram Panchayat shall enclose exact drawing of the vending zone with the declaration and provide the space of minimum of 4x4 ft dimensions for each rural street vendor in the vending zone.
- 4. The Gram Panchayat, by resolution, passed in its general or special meeting, shall declare "natural market(s)" specifying the marketplace(s), where sellers and buyers have traditionally congregated for the sale and purchase of products or services. These natural markets shall also be considered for declaring as vending zones by the Gram Panchayat.
- 5. Every person, who has completed the age of eighteen years or such age as may be prescribed by the appropriate Government, and wishes to carrying out rural vending activities, in the rural area shall apply, for license, to the concerned Gram Panchayat, on the form "B", appended to these Model bye-laws and shall also deposit one time license/registration fee, at such rate as may be fixed by the Director (Rural Dev. and Panchayati Raj) from time to time. The preference shall be given to the bonafide resident of Himachal Pradesh, while issuing the license. The Gram Panchayat shall record the details in the register of rural vendors to be maintained by the Gram Panchayat in form "C".
- 6. (1) On receipt of the application, the Gram Panchayat shall forward the application for police verification and upon receipt of police verification report, consider the application and take appropriate decision thereon. Every rural street vendor, as decided by Gram Panchayat, shall be issued a vending license, in form "D" appended to these Model bye-laws, for Stationary and Mobile Vendor, as the case may be, by Gram Panchayat, subject to such terms and conditions, specified in the said license. It shall be mandatory for the rural street vendor to keep this license, in his/her possession, while carrying out the vending activities and he shall be liable to produce the same to the general public, authorities of the State Government and the Gram Panchayats as and when so required.
- (2) In case, a person requires rural street vendor license in respect of more than one Gram Panchayat, he shall apply to the Block Development Officer in Form "B-I", who shall, after police verification and receipt of requisite fees, grant license in Form "D-I".
- 7. (1) The vending license shall be issued under any of the following categories, namely:—
 - (a) a stationary vendor; or
 - (b) a mobile vendor;
- (2) The vending license, issued for the categories specified in clause (1) shall specify the vending zone (s), where the street vendor shall carry on his vending activities, the days and timings for carrying out such vending activities and the conditions and restrictions, subject to which he/she shall carry on such vending activities. The license for vending eatables will be issued, on the production of Food Safety and Standard Authority of India (FSSAI) license.

- 8. The number of licenses shall be restricted to a maximum number arrived at by calculating the 2.5% of the population of concerned Gram Panchayat. For issuing vending license to a rural street vendor, preference will be given to those persons who are bonafide residents of Himachal Pradesh and the persons, who are already carrying out the vending activities in the Gram Panchayat area.
- 9. Every rural vendor, who has been issued the vending license, shall *pay such vending fees*, as may be fixed by Director, *Rural Dev. & Panchayati Raj*, from time to time.
- 10. (1) Every vending license shall be valid for the period of one year, from the date of issue.
- (2) Every vending license, after its expiry, can be renewed after one year, on payment of such fees, as may be decided by Director, *Rural Dev. & Panchayati Raj* from time to time. Renewal shall be done by the Panchayat Secretary, without taking fresh approval from Gram Panchayat, unless any wrongful activity on the part of such license holder has come into his notice. In the latter case, the matter will be submitted for the decision of the Gram Panchayat.
- 11. Where a rural street vendor, who has been issued a vending license under these Model bye-laws, commits breach of any of the conditions thereof or where the Gram Panchayat is satisfied that such vending license has been secured by the rural street vendor, through misrepresentation or fraud, the Gram Panchayat may, cancel the vending license or suspend for such period as it deems fit:

Provided that no such cancellation or suspension shall be made by the Gram Panchayat, unless an opportunity of hearing has been provided to the street vendor.

12. (1) If the rural vendor fails to vacate the place specified in the vending license, after the lapse of the period specified the vending license and the Gram Panchayat deems it necessary, it may seize the goods of such rural street vendor:

Provided that where any such seizure is carried out, a list of goods, so seized, shall be prepared, as specified in the scheme, and a copy thereof, duly signed by the person authorized to seize the goods, shall be issued to the rural street vendor concerned.

(2) The street vendor, owning the goods which have been seized under sub-section (1) may, reclaim his goods, in such manner, and after paying such penalty, as may be specified by the Director, Rural Development & Panchayati Raj:

Provided that in case of non-perishable goods, the Gram Panchayat shall release the goods, within two working days of the claim being made by the rural street vendor, and in case of perishable goods, the Gram Panchayat shall release the goods on the same day on which claimhas been made by the street vendor.

CHAPTER III: DISPUTE REDRESSAL MECHANISM

13. Every rural street vendor, who has a grievance or dispute, may make an application in writing to the Sub-Divisional Officer (Civil) concerned. The application shall be on plain paper and shall have the description of the matter of the grievance or dispute and shall contain the signatures or thumb impression of the applicant. On receipt of grievance or dispute, the Sub-Divisional Officer (Civil) shall, after verification and enquiry as may be deemed necessary, take steps for expeditious redressal of such grievance or resolution of such dispute, within 15 days of the receipt of the application for redressal or resolution of grievance or dispute.

14. In case the government departments, institutions, have any dispute or objections to the actions or the orders of the Gram Panchayat under these Model bye-laws, they may raise the objection/dispute to the Sub-Divisional Officer (Civil) of the area concerned who shall decide the matter expeditiously.

CHAPTER IV: PENALTY

- 15. If any Rural Street vendor;
- (a) indulges in vending activities without the vending license;
- (b) contravenes the terms of vending license; or
- (c) contravenes any other terms and conditions specified for the purpose of regulating rural street vending under these Model bye-laws, he shall be liable to be imposed a penalty by the Gram Panchayat which may extend to one thousand rupees, and if the breach is a continuing breach, with further penalty, which may extend to ten rupees for every day after the first day, during which the breach continues:

Provided that recurring penalty shall not exceed the sum of five thousand rupees. The penalty, if not paid, shall be recovered as arrears of land revenue.

CHAPTER V: MONITORING

16. The Block Development Officer of the area concerned, shall be responsible for the implementation of these Model bye-laws, in his jurisdiction and shall also keep up to date record having the Gram Panchayat wise details of the number of rural vendors in his jurisdiction. He shall review the compliance of these Model bye-laws, with the Gram Panchayats regularly. Deputy Commissioner at District level shall also review the compliance of these Model bye-laws from time to time.

CHAPTER VI: POWERS TO REMOVE DIFFICULTIES

17. If any difficulty arises in the interpretation or implementation of these Model byelaws, the matter may be referred to the State Government for clarification/guidance, who shall be competent to remove such difficulty or issue necessary clarifications/guidelines.
