No. TCP-F05/5/2023.—Whereas some areas have been included in the Dhaulakuan-Majra Planning Area and its limits have been re-defined under sub-section (2) (a) of Section 13 of the Himachal Pradesh Town and Country Planning Act, 1977 (Act No. 12 of 1977) notified *vide* the Notification of TCP-F05/5/2023 number, dated 20-08-2024.

And whereas, the existing land use of the newly included areas of the said Planning Area has not yet been published under sub-section (1) of Section-15 of the Act *ibid*;

And whereas, the Governor of Himachal Pradesh is satisfied that in the aforesaid newly included areas of the Planning Area, the change of land use or any building operation therein is likely to cause injurious disturbance of the surface or any land or soil, or is considered detrimental to the preservation of the soil, prevention of land slips or protection against erosion and is likely to make it difficult to plan and develop the areas in question in accordance with the provisions of the aforesaid Act.

Now, therefore, in exercise of the powers conferred by sub-section (1) of Section 15-A of the Act *ibid*, the Governor of Himachal Pradesh is pleased to freeze the existing land use of the newly included areas of the **Dhaulakuan-Majra Planning Area** from the date of publication of this Notification in the Official Gazette for a period of five years.
