यदि कोई व्यक्ति जिसे प्रस्तावित नियमों बाबत कोई आक्षेप/सुझाव हैं; तो वह लिखित आक्षेप (पों) या सुझाव (वों) को निदेशक, पंचायती राज, हिमाचल प्रदेश एस. डी.ए. कॉम्प्लेक्स कसुम्पटी, शिमला–171009, को, प्रस्तावित नियमों के राजपत्र (ई-गजट), हिमाचल प्रदेश में प्रकाशन की तारीख से पन्द्रह दिन की अवधि के भीतर भेज सकेगा;

उपरोक्त नियत अवधि के भीतर प्राप्त हुए आक्षेप (पों) या सुझाव (वों), यदि कोई है/हैं, पर प्रस्तावित प्रारूप नियमों को अंतिम रूप देने से पूर्व राज्य सरकार द्वारा विचार किया जाएगा, अर्थात् :-

प्रारूप नियम

- 1. संक्षिप्त नाम और प्रारम्भ.—(1) इन नियमों का संक्षिप्त नाम हिमाचल प्रदेश पंचायती राज (निर्वाचन) तृतीय संशोधन नियम, 2025 है ।
 - (2) ये नियम राजपत्र (ई-गजट) हिमाचल प्रदेश, में इनके प्रकाशन की तारीख से प्रवृत्त होंगे।
- 2. नियम 9 का संशोधन 2.—हिमाचल प्रदेश पंचायती राज (निर्वाचन) नियम, 1994 (जिसे इसमें इसके पश्चात् उक्त नियम' कहा गया है) के नियम 9 के उप-नियम (2) के स्थान पर निम्नलिखित परंतुक जोड़ा जाएगा, अर्थात्:—

"परन्तुक जहां जिला परिषद की क्षेत्रीय निर्वाचन क्षेत्रों के मध्य जनसंख्या में पर्याप्त भिन्नताएं पाई जाती हैं, जैसा कि इस उप-नियम के अन्तर्गत अवधारित किया गया है और उप-नियम (4) के अनुसार प्रकाशित किया गया है, तथा जहां मसौदा प्रस्ताव के संबंध में उपायुक्त को आक्षेप या सुझाव प्राप्त होते हैं, वहां उपायुक्त, ऐसे आक्षेपों या सुझावों पर विचार करने के पश्चात् पंचायत समितियों की सीमा का उल्लंघन कर सकेगा। ऐसा उल्लंघन केवल जनसंख्या के समायोजन हेतु भौगोलिक परिस्थितियों, प्रशासनिक सुविधा एवं निर्वाचन—क्षेत्रों के मध्य जनसंख्या असमानता को दूर करने के उद्देश्य से किए जाएंगे, शर्त के अध्यधीन क्षेत्रीय निर्वाचन—क्षेत्रों की कुल संख्या, हिमाचल प्रदेश पंचायती राज अधिनियम, 1994 की धारा 89 (2) के अन्तर्गत निधारित संख्या से अधिक न हो।"

The objection(s) or suggestion(s), if any, received within the period stipulated above shall be taken into consideration by the State Government before finalizing these draft rules, namely:—

DRAFT RULES

- 1. Short title and commencement.—(1) These rules may be called the Himachal Pradesh Panchayati Raj (Election) Third Amendment Rules, 2025.
- (2) These rules shall come into force from the date of their publication in Rajpatra (e-Gazette), Himachal Pradesh.
- **2. Amendment of rule 9.**—In sub-rule (2) of rule 9 of Himachal Pradesh Panchayati Raj (Election) Rules, 1994, the following proviso shall be added, namely:—

"Provided that where substantial variations exist in the population among the territorial constituencies of the Zila Parishad as determined under this sub-rule and published in accordance with sub-rule (4), and where objections or suggestions regarding the draft proposal are received by the Deputy Commissioner, the Deputy Commissioner may, after considering such objections and suggestions, transgress the boundaries of the Panchayat Samities. Such transgressions to adjust the population shall be made with regard to geographical conditions and administrative convenience to address population variations among constituencies, subject to the condition that the total number of territorial

constituencies shall not exceed the number determined under section 89(2) of the Himachal Pradesh Panchayati Raj Act, 1994."
